to be filled at the earliest possible date.

The chair is structurally assigned to the Department of Psychiatry and Psychotherapy and will further develop the core theme of evidence-based early detection and care for young people with affective disorders in its national and international significance. The focus will be on clinical research including health care research with promotion of a close collaboration with the Center for Evidence-Based Healthcare (ZEGV), the Else Kröner Fresenius Center (EKFZ) for Digital Health and the Institute and Policlinic for Occupational and Social Medicine (IPAS). Prospectively, gender-dependent aspects are also to be explicitly taken into account and intersectional relationships are to be made visible. In the Department of Psychiatry and Psychotherapy, you (m/f/x) will be responsible for the clinical man-agement of the training and further education track for evidence-based early care for young people. In addition to excellent research and teaching, we expect you to play an active role in the public dis-course on evidence-based early detection and care for young people with affective disorders. Fur-thermore, you will develop and strengthen interfaces between university and community early detec-tion and intervention approaches based on your expertise in the active participation in relevant pro-fessional societies and networks. We strongly support your active participation in the existing re-search networks at the University Hospital Carl Gustav Carus and TUD, specifically in the SFB-Transregio 393 "Trajectories of Affective Disorders" and the International Research Training Group IRTG 2773 "Risks and Pathomechanisms of Affective Disorders".

As a professor, you will represent the field of evidence-based early detection and care for young peo-ple with affective disorders in adults in research and teaching. With that you will specifically strength-en the key area of the faculty "Neurological and mental health disorders" and its interconnected clus-ters "Prevention and Public Health" and "Medical data science and smart technologies". We would also like to see a future strengthening of diversity-sensitive research and teaching in the subject.

We are looking for a nationally and internationally recognized personality with high social competence and comprehensive expertise in the field of evidence-based early detection and psychiatric treatment of young people with affective, especially bipolar, disorders. In addition, you have several years of experience in teaching students of human medicine, epidemiology and public health as well as in the development of modern academic programs inspiring our students including doctoral students with your effective and modern teaching, and bring a high level of academic commitment and willingness to engage in constructive, interdisciplinary collaboration in research and teaching. You are experi-enced in the supervision of doctoral students and academic self-regulatory bodies including heading faculty committees. Appointment requirements include a completed university degree in human medicine, a doctorate and habilitation or equivalent achievements with international publications and successful acquisition of third-party funding in the subject of the denomination of this chair in large-scale research projects and networks including heading of the aforementioned, board certification for psychiatry and the permission to work clinically in Germany, as well as expertise in the conceptual development, clinical heading and budget responsibility for the outpatient, day care and inpatient care structures associated with the denomination and proof of extensive teaching experience of sev-eral years. A degree in epidemiology would be desirable. In all other respects, the requirements for appointment, the official duties and the administrative status are governed by §§ 59, 69, 71 of the Act on Higher Education Institutions in the Free State of Saxony (SächsHSG) and the Regulations on Du-ties and Responsibilities at Higher Education Institutions (HSDAVO).
