to be filled at the earliest possible date.

The chair is structurally assigned to the Clinic and Polyclinic for Neurology of the University Hospital Carl Gustav Carus Dresden and particularly strengthens the research focus of "Neurological Diseases" of the Faculty of Medicine and its areas of "interdisciplinary neurological acute and emergency medicine", "special neurological intensive care medicine", "adjuvant intensive care therapies in the context of brain damage" and "sophisticated neuromonitoring". The chair is linked to the position of lecturer for the subject of neurology at the Carl Gustav Carus Faculty of Medicine as well as the leading management of the neurological intensive care unit and the neurological sub-area of the central emergency room. As the future position holder, you (m/f/x) will, in addition to the expected research and teaching activities, also take on tasks in patient care and administrative tasks at the clinic.

As a future professor at our faculty, you will support cross-location, patient-oriented clinical research and participation in joint clinical studies at the Department of Neurology. Furthermore, the implementation of innovative clinical studies, the establishment of scientific collaborations and, specifically, interaction with the Institute of Biomedical Engineering in the field of neuromonitoring are required. In addition, your active participation in the development of joint priority projects as part of the university's future strategies is also expected. We are also pleased about your willingness to take on tasks in academic self-administration.

Ideally, you conduct research in the field of interdisciplinary and specific neurological acute and intensive care medicine and are already recognized nationally and internationally and want to focus on the further development of the research focus (neurological acute care in the preclinical and central emergency rooms, clinical intensive care medicine, neuromonitoring) as well as neurological teaching on site. You are expected to demonstrate experience in acute and intensive care medicine that goes beyond the specialist area of neurology, as well as the willingness and ability for interdisciplinary networking with the other departments in acute and intensive care medicine at the University Hospital Dresden.





We are looking for a person with national and international research experience. Ideally, you are already known through internationally visible publications related to the field of appointment and have experience in obtaining competitive third-party funding. Proven and well-founded experience in managing an intensive care unit in all areas is required. You also have extensive experience in the area of student teaching, have already implemented your own innovative teaching projects and have already worked as a lecturer. We expect a completed university degree in human medicine, proof of qualification as a specialist in neurology and the additional qualifications in “intensive care medicine”, “clinical acute and emergency medicine” and also “out of hospital emergency medicine”. In order to implement the tasks, you must demonstrate sound clinical and scientific experience in interdisciplinary intensive care medicine through activities outside of specialist neurological intensive care medicine as well as several years of work in emergency services and in-hospital interdisciplinary emergency room management. As part of clinical patient care, experience in the areas of palliative medicine, quality management and participation in certification processes are required. In order to use the scientific potential of TUD in the future, special medical technology expertise must be demonstrated, particularly in the area of neuromonitoring. In all other respects, the requirements for appointment, the official duties and the administrative status are governed by §§ 59, 69, 71 of the Act on Higher Education Institutions in the Free State of Saxony (Sächs-HSG) and the Regulations on Duties and Responsibilities at Higher Education Institutions (HSDAVO).

The Faculty of Medicine strives to employ more women professors in academia and research. We therefore expressly encourage women to apply. The University is a certified family-friendly university and offers a Dual Career Service. We welcome applications from candidates with disabilities.
